Rationale

We decided that a collaborative approach, which is recommended, NMC (2009), would be essential when the curriculum was reviewed for revalidation of our Bachelor of Midwifery programme.

We had also decided to develop and validate an undergraduate Masters of Midwifery programme during this process.

The midwifery competency books and grading tool were also included in this process as there is evidence and are many challenges around the grading of clinical practice (Chenerey- Morris, 2014. Donaldson & Gray, 2012).



Collaborative Team

- Midwifery Lecturers
 - Programme leader and 3 others
- Clinical Mentors from 2 Health Boards
 - Birth Centre Manager
 - Inpatient Sign Off Mentor
- Practice Education Facilitators –one from each Health Board
- Student Midwives
 - 2 students from third year
 - 1 student from second year
- Service Users
 - 2 representatives from Maternity Services Liaison Committee
 - 1 representative from 'Dads Rock'
 - 1 representative from 'Twins' Group



Curriculum and Clinical Practice Documentation Design

Revalidation process included setting a timescale which started January 2015

A series of monthly meetings were held First two meetings were held by university staff Subsequent meetings involved other stakeholders





Curriculum and Clinical Practice Documentation Design

Initially

- Reviewed the evaluations and audits from exiting programme
- We scoped documentation from 3 other universities
- Developed an action plan



Key Changes

New Clinical Competency Books

- Removal of repetitive statements and competencies
- Add Medicine Administration assessment
- Add breast feeding clinical skills review (BFI accredited programme)
- More detailed introduction around roles and responsibilities
- Discussed service user feedback inclusion
- General design and layout
- Grading tool



Outcomes

- Enhanced Partnership with Practice and Service Users
- New Clinical Practice Documentation
- New grading tool designed and implemented
- Staff development consistency in mentorship preparation
- Strengthen Student Experience- ownership, value and credibility



Next Steps

- Evaluation of the grading tool
- Feedback on the new documentation
- Write and review the results of the above
- Midwifery team will be involved in the development of a national competency assessment process
